- Matches are played on Tuesdays and Thursdays at 6:00 pm, starting June 12
- Each team will have home and away matches. Your home match site should have four courts, preferably lighted. For help in securing a site for home matches, contact Donn Gobbie at 219-629-3821 or dgobbie@hotmail.com
- USTA Liability Insurance will be provided if your home site requires
- League fee is \$18.00 per person. **USTA membership is not required** (if you are not a USTA member, you will need to create a guest account – see below)
- Minimum of four boys and four girls recommended for each team. You are not obligated to play in every match. Play whenever you want, but at least two boys and two girls from your team **must be present** for each home and away match.
- Format includes 16 short sets: four sets of boys' singles, two sets of boys' doubles, four sets of girls' singles, two sets of girls' doubles, and four sets of mixed doubles. Each player is limited to two singles sets, two doubles sets, and two mixed doubles sets.
- For each home match, your team must provide four **unopened** cans of tennis balls
- Team IDs are listed on next page. If you do not see your town or city listed, contact Donn Gobbie at 219-629-3821 or dgobbie@hotmail.com
- If the minimum number of players do not register for your team, you will have the choice of a refund or placement on another team

How to Register

1. Go to www.usta.com and click on TennisLink at top of page, then click on Junior Team Tennis
2. Click on Have a Team ID? and enter your team ID (see next page)
3. Enter your USTA membership number. If you are not a USTA member, click on Sign up as a Non-Member. Follow instructions and be sure to write down your ID number at the end of the process. If you are 13 years of age or younger, a parent or guardian must create your account. See third page of this document.
4. Proceed to check-out and pay the league fee of \$18.00

HOW TO CREATE A USTA ACCOUNT FOR PLAYERS UNDER 14



First - as a parent, you'll need to create a free USTA account for yourself.
USTA players under 14 must be linked to a parent account

- Go to www.usta.com
- At the upper right-hand part of the page - click on TennisLink
- Click "Don't have a USTA Account? Learn more and create one today"



- Click CREATE ACCOUNT, under Do you play in a USTA Program (Team Tennis, USTA Flex Leagues, Tournaments) without a USTA Membership?

- Select "I am new to TennisLink and want to create a new account"

- Click NEXT
- Fill out the form with your information (NOT your child's information)
- Enter and confirm Password
- Click NEXT to login to your new account

Now you can create an account for your child

- Logout of TennisLink
- Repeat the steps to create an account, but include your child's information



- Click NEXT
- Check box: "By checking the box, you are confirming that you are the parent or legal guardian of the person for whom the account is being created"

- Click CONTINUE
- You will then be prompted to LOGIN to your USTA Account

- Enter your email and password, then click NEXT
- Complete child account profile and click NEXT
- This should bring you to the My Tennis page and allow you to click Switch Profile to view your child's USTA profile. If you do not see this link please contact USTA Member Services
